Consignment & Authenticity Agreement

We offer 2 ways to sell: 1) directly to us, 2) on consignment. Please read this agreement carefully.

Item Criteria

- 1) AUTHENTIC high-end designer brand. E.g Chanel, Louis Vuitton, Bottega Veneta, Celine, Christian Louboutin, Dior, Hermes, Alexander Wang, Chloe, Fendi, Miu Miu, Prada, Salvatore Ferragamo, Valentino, Saint Laurent, MCM, Alviero Martini, Redmoon, Redwing, Gregory.
- 2) Like-new to gently-used condition.
- 3) Ideally some sort of supplementary information that supports authenticity (original receipt, authenticity card, name/location/approximate date it was purchased).

NOTE: IT IS ILLEGAL TO BUY OR SELL COUNTERFEIT LUXURY GOODS. ROYALUXE BOUTIQUE WILL NOT BUY OR SELL COUNTERFEIT ITEMS AND WILL IMMEDIATELY RETURN OR DESTROY ITEMS DEEMED COUNTERFEIT.

Process

Upon receipt, ROYALUXE BOUTIQUE will be responsible for the promotion and customer service associated with selling your items, market price evaluation, photography, detailed description, In-store merchandising, Internet listing, customer communication, and if required - secure packaging, and shipping. We will take all necessary steps to sell your item quickly for the best price possible. If your item comes as not authentic, we will then either return the item to you or destroy it.

Payments

We issue consignment payments via cash or online transfer once the item has sold.

Selling Option 1: Direct Buy – The Fast Cash Option

We will buy select items outright for a fair value after authenticity has been verified. Typically, direct Buy is the quickest way to sell.

Selling Option 2: Consignment – Wait Patiently, then Get the Most Cash

We will use our boutique, online store, customer base and other selling avenues to sell your authentic high-end designer items at a price that we quote. However, the selling price will be mark up accordingly.

We cover all sales transaction expenses such as credit card fees, PayPal fees and all the process expenses detailed above, including shipping if necessary. If your item has not sold after 60 days, it can be returned to you.

Consignment Term & Item Pricing

The consigner will be consulted on any further price reduction.

Cancellation Clause: If contract is terminated before 60 days there will be a RM50 cancellation fee.
